Internal Quality Assurance Cell (IQAC)

Academic Session 2024-25

The Internal Quality Assurance Cell (IQAC) of Government College Bound Kalan, Charkhi Dadri met several times during the academic session 2024-25 to plan, monitor and evaluate quality-enhancement measures in teaching, learning and overall institutional functioning. The following Action Taken Report summarises the key decisions recorded in the minutes of meetings and the specific steps implemented during the year.

1. Confirmation of Previous Minutes and API Verification

In each meeting, the coordinator presented the minutes of the previous sitting for confirmation. All members read and approved these without modification. The Academic Performance Indicators (API) of faculty members—including the API of Smt. Naveen Kumari (Department of Sociology) for the years 2015-20 and of all other staff for the session 2023-24—were scrutinised and verified as per Haryana Government and UGC norms.

2. Parent-Teacher Meetings

The IQAC resolved to institutionalise Parent-Teacher meetings in both semesters. Accordingly, meetings were organised in each term to share student progress, attendance, and co-curricular achievements with parents. Feedback received during these interactions was documented and shared with department heads for necessary action, such as providing remedial classes and mentoring support for students requiring additional help.

3. Best Practices for NAAC and Quality Enhancement

To strengthen NAAC preparedness, every meeting included a discussion on identifying and sustaining “Best Practices.” Departments documented their ongoing initiatives—such as environmental awareness drives, digital teaching aids, and gender-sensitisation programmes—and submitted reports to IQAC. Two key best practices were short-listed for the upcoming NAAC cycle and have been formally adopted by the college.

4. Tree Plantation and Green Campus Activities

The IQAC decided to hold tree-plantation drives under the NSS and Women’s Cell. Multiple plantation programmes were conducted during the monsoon season within the campus and in neighbouring villages.

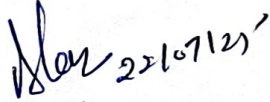

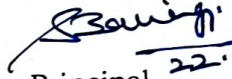
